<u>Sussex news</u></u>. Already in the newsletter mention was made of Sussex gaining promotion to Division One in the County Championship, so some different and possibly more testing opponents for us to watch next year. Sussex have an opportunity to win the division two title in the last round of matches when Sussex face Middlesex at Hove. Recently there have been a couple of comprehensive wins over firstly Derbyshire and then Gloucestershire, amassing large totals in the first innings and dismissing the opposition chiefly twice. Jaydev Unadkat who again looks an outstanding left arm bowler, leading the attack and well supported by Ollie Robinson. The batting unit as a whole including the lower order have made considerable runs for instance John Simpson another big hundred against Derbyshire, Jack Carson contributing significant low order runs. Carson's runs have gone with a series of five wicket hauls with the ball emphasising his all-round development. Above all I suspect that Daniel Hughes's contribution at the top of the order getting the innings off to a solid start with impressive stroke play has been a real bonus.

So it came as some disappointment to hear that Hughes missed the game at Bristol and will also miss the final game of the season due to being called back by New South Wales in advance of their season. I notice that NSW's first one day cup game is on 22nd September with the Sheffield Shield season starting on the 8th October. Is this going to be a sign of difficulties in recruiting overseas players for a full English season with the increasing elongation off domestic seasons? For instance, the English county season now runs from very early in April through to virtually the end of September and the Australian season runs from late in September through to late March. Hughes' departure is unfortunate for Sussex but could possibly be a sign of domestic scheduling around the world.

Congratulations also to Surrey on winning the First division of the county championship their third in succession and with a round to spare. They continue to set the standards for others to follow.

<u>Vitality Blast T20s Finals day</u>. A disappointing day for Sussex losing to Gloucestershire in their semi-final, Gloucestershire, on paper before the day were possibly the weakest of the four sides, yet with good seam/swing bowling went on to be T20 champions. Sussex never recovered from losing Daniel Hughes early on and from that point on seemed to be on the back foot, still a good T20 season.

Clubs – Sussex Premier League – There were twists and turns in the last two weeks of the of the league season. On the penultimate Saturday Preston Nomads lost to East Grinstead (East Grinstead had a strong second-half of the season, had they matched it in the first half might well have been pushing at the top of the table). On the same day Three Bridges beat Middleton to go joint top with Nomads, would the count back decider come into play? At the foot Hastings had a comfortable win over Bognor giving them a chance to avoid relegation. So, to the final Saturday which was marred by rain, all games suffering to one degree or another. Nomads beat Cuckfield quite convincingly then Three Bridges went down by just sixteen runs to Roffey so congratulations to Nomads winning the title. At the bottom Bognor's game at East Grinstead was abandoned giving Hastings an opportunity of salvation if they could beat Horsham at home. Like all other games this was reduced in overs only for Hastings to suffer a last over one wicket loss to Horsham, this result saw Horsham finishing in second place above Three Bridges. This narrow loss for Hastings saw them join Worthing as the two relegated clubs. Promoted from Division 2 are Ifield (top of division 2) and Haywards Heath. So next season there will be no East Sussex club in the Premier League.

<u>Heritage Open days</u> have become the popular feature in England with various historical and other community places opening their doors to the public. This year the Sussex Cricket Museum was one of the local attractions open to the public offering a tour of the Country Ground hosted by Phil Barnes.
